SECTION I: INSTRUCTIONS TO BIDDERS

1. Rights of Public Entity

The Eenhana Town Council reserves the right:

- (a) to split the contract as per the lowest evaluated cost per item, or
- (b) to accept or reject any quotation; and
- (c) to cancel the quotation process and reject all quotations at any time prior to contract award.

2. Preparation of Quotations

You are requested to quote for the items mentioned in Section III by completing, signing and returning:

- (a) the Quotation Letter in Section II with its annex for *Bid Securing Declaration*.
- (b) the List of Goods and Price Schedule Section III.
- (c) the Specifications and Compliance Sheet in Section V.
- (d) Attach letters of reference of previous work done, and
- (e) Attached a Certificate of Fitness.

You are advised to carefully read the complete Request for Sealed Quotations document, including the Special Conditions of Contract in Section VII, before preparing your quotation. The standard forms in this document may be retyped for completion but the Bidder is responsible for their accurate reproduction.

3. Validity of Quotations

The Quotation validity period shall be *30* days from the date of deadline.

4. Eligibility Criteria

To be eligible to participate in this Quotation exercise, you should:

- (a) have a valid original / certified company Registration Certificate.
- (b) have a valid original / certified copy of Good Standing Tax Certificate.
- (c) have a valid original / certified copy of Good Standing Social Security Certificate.
- (d) have a valid certified copy of Affirmative Action Compliance Certificate, proof from Employment Equity Commissioner that bidder is not a relevant employer, or exemption issued in terms of Section 42 of the Affirmative Action Act, 1998.
- (e) Submit signed Bid-securing Declaration.
- (f) Submit a fitness certificate.
- (g) Submit a fitness certificate of area of operation.
- (h) Attach 3 letters of reference from corporate entities, of previous works done specifically for Catering Services of a magnitude event for at least 300-350 people.
- (i) Provide pictures as evidence of similar nature of works (corporate events)

(j) Submit a Certified copy of identification document (ID's) of owner of the company

4.1 Evaluation Criteria

- 1. Documents to be fully completed with black ink.
- 2. No eraser fluid (tipex) to be used.
- 3. All pages to be initialled and signed where applicable by the person authorizing the bid.
- 4. All corrections are to be initialized.
- 5. The principal business should be in line with services required (Catering related).

5. Bid Securing Declaration

Bidders are required to *submit a Bid Securing Declaration* for this procurement process.

6. Delivery

Delivery shall be **21 days** after acceptance/ issue of Purchase Order. Deviation in delivery period *shall be considered if such deviation is reasonable*.

The following tests and inspections will be conducted on the goods at delivery:

- a) Adherence to quality and quantity specifications
- b) Adherence to tender conditions as set herein

7. Sealing and Marking of Quotations

Quotations should be sealed in a single envelope, clearly marked with the **Procurement Reference Number, addressed to the Public Entity with the Bidder's name and contact information at the back of the envelope**.

8. Submission of Quotations

Quotations should be deposited in the Quotation/Bid Box located at Eenhana Town Council, 108 Church Street not later than 7th June 2024 @10H00. Quotations by post or hand delivered should reach Eenhana Town Council, 108 Church Street by the same date and time at latest.

Late quotations will be rejected.

Quotations received by e-mail or fax will not be considered.

9. Opening of Quotations

Quotations will be opened internally by the Public Entity immediately after the closing time referred to in instruction 8 above. A record of the Quotation Opening stating the name of the bidders, the amount quoted, the presence or absence of a Bid Securing Declaration, will be posted on the website of the Public Entity and available to any bidder on request within three working days of the Opening.

10. Evaluation of Quotations

The Public Entity shall have the right to request for clarifications in writing during evaluation. Offers that are substantially responsive shall be compared on the basis of price or ownership cost, subject to Margin of Preference where applicable, to determine the lowest evaluated quotation.

11. Technical Compliance

Bidders shall submit along with their quotations documents, catalogues and any other literature to substantiate compliance with the required specifications and to qualify deviations if any with respect to Public Entity's requirements.

The Specifications, Performance Requirements and Compliance Sheet details the minimum specifications of the goods/items to be supplied. The specifications have to be met but no credit will be given for exceeding the specifications.

12. Prices and Currency of Payment

Prices will be submitted in Namibia dollars only. However, Eenhana Town Council may allow for prices to be adjustable to change in rates of exchange of currency, price variation etc. depending on the behaviour of the market in respect of the specific goods items being procured.]

Prices shall be fixed in Namibian Dollars.

13. Margin of Preference

13.1. The applicable margins of preference and their application methodology are as follows:

14. Award of Contract

15. Notification of Award and Debriefing

The Eenhana Town Council shall after award of contract promptly inform all unsuccessful bidders in writing of the name and address of the successful bidder and the contract amount and post a notice of award on its website within seven (7) days. Furthermore, the Public Entity shall attend to all requests for debriefing made in writing within seven (7) days of the unsuccessful bidders being informed of the award.

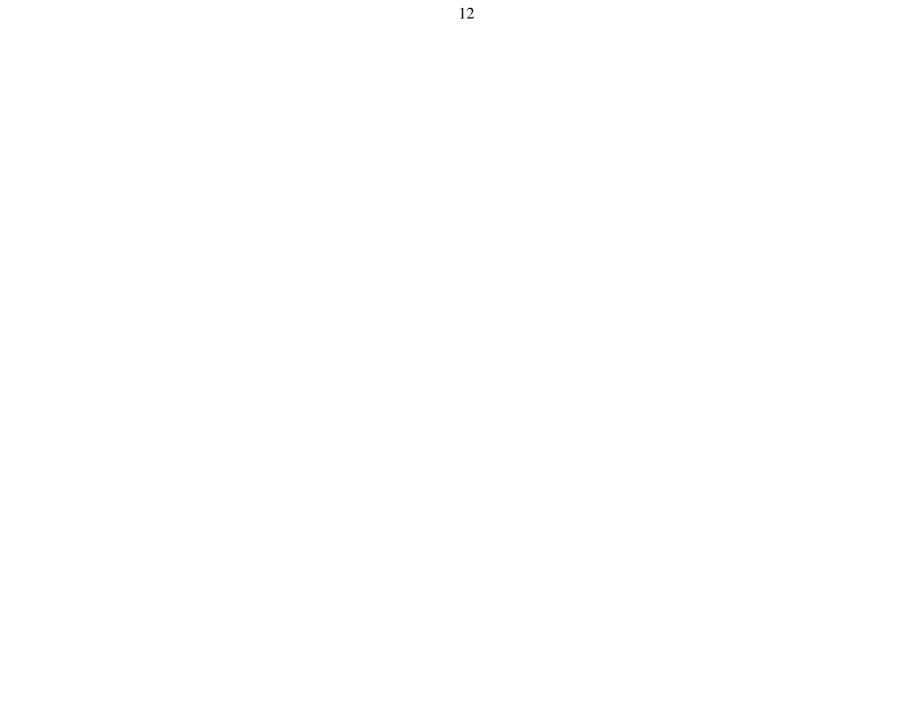
